NICOLAE V. DURĂ, Professor, JD, born in 1945 in Romania. He obtained his Bachelor's and Master's degrees in theology from the Theological Institute of University Rank in Bucharest; followed by PhD in Canon Law (1981) in the same University after completing his PhD studies and research in the field of Canon Law in Ethiopia; doctoral and postdoctoral studies and research in France (Catholic Institute and Sorbonne University of Paris) and in Greece (Aristotelian University of Thessaloniki). In 1997 he obtained a degree of Doctor in Canon Law at the Pontifical University of Toulouse (France); and in 2002 — Doctor Honoris Causa granted by the Humanist Sciences University of Ostrog (Ukraine); 2010 — Doctor Honoris Causa — the St. Kliment Ohridski University of Sofia (Bulgaria); 2015 — Doctor Honoris Causa — the Ivane Javakhishvili State University from Tbilisi (Georgia). Professor Emeritus of the Ovidius University of Constanța (2012—). He is a member of the following scholarly organisations: Academy of Romanian Scientists, Society of the Law of the Oriental Churches, based in Vienna; the International Consortium for Law and Religion Studies, Faculty of Law, University of Milan. Professor of Theological Institute of University Rank in Bucharest (1976—2001) and Professor of the Faculty of Law and Faculty of Theology of the Ovidius University in Constanta (2001—). Vice Dean (for Education and Research) of the Faculty of Law, Ovidius University of Constanța (2004—2008); Vice Rector of the Ovidius University for Inter-University Relations and Foreign Students (2008—2012). Prizes: The National Order of Merit (version of the Legion of Honour, Cultural Merit), awarded in 2001 by the President of France, Jacques Chirac, at the proposal of the Minister of External Affairs for his contribution to the promotion of the French language and European culture due to his book, amounting to more than

1,000 pages, *Le Régime de la synodalité selon la législation canonique, conciliaire, oecuménique, du Ier millénaire*, published in Bucharest in 1999; A. D. Xenopol Award granted by Romanian Academy in 2001 etc. Author of books, studies and articles (on theology, canon law, law, history, ecclesiology, the history of ancient literature, philosophy etc.), amounting to thousands of pages published in different languages.

TOMASZ GAŁKOWSKI CP, Professor UKSW, born in 1967, he graduated from the Pontifical Faculty of Theology “Bobolanum”: SJ in Warsaw. In the years 1991—1995 he studied canon law at the Pontifical Gregorian University in Rome, where on the basis of the dissertation “Il quid ius nella realta umana e nella Chiesa” he received his doctoral degree. He was awarded with the Bellarmin’s Prize for his publication (*Analecta Gregoriana* 269, Roma 1996). In 2007, he received a postdoctoral degree at the Faculty of Canon Law of the University of Card. St. Wyszyński in Warsaw. His monograph *Right-Duty. Priority and interdependence in the law orders: Canonical and the secular society* was awarded with the Prize of the Rector of the University. He is an author of about 70 scholarly publications. His research interests include issues related to the *ratio legis* of the canonical norms and issues of common law and canon law. Currently he is a professor and director of the chair of the Theory of Canon Law at this University.

MICHAŁ HUCAŁ, PhD in ecclesiastical law at the Christian Academy of Theology in Warsaw; master of arts in legal science at the Warsaw University; author and co-author of many publications related to human rights and ecclesiastical law, for example, *Wolność sumienia i wyznania w orzecznictwie ETPCz* (2012), *Oddziaływanie brytyjskiej ustawy o prawach człowieka z 1998r. na Kościół Anglii* (2015), *Prawo małżeńskie Kościołów chrześcijańskich w Polsce a forma wyznaniowa zawarcia małżeństwa cywilnego* (2016), *Prawo Kościoła Ewangelicko-Augsburskiego. Komentarz* (2017), *Ewangelickie Prawo Kościelne 1918-2018. Zbiór tekstów prawnych Kościołów ewangelickich w Polsce* (2018), *Wielowymiarowość ewangelickiego prawa kościelnego. Analiza porównawcza i teologiczno-prawna* (2018), *Prawo do prywatności w Kościołach i innych związkach wyznaniowych: od tajemnicy duszpasterskiej do ochrony danych osobowych* (2019).

PIOTR KROCZEK, Catholic priest, professor of law, doctor of ecumenical theology, judge in Tribunal of Archdiocese of Cracow, chairman of the General Norms and Legal Theory Department at the Faculty of Canon Law at the Pontifical University of John Paul II in Cracow; he majored in legal theory and denominational law, and data protection.

DAMIAN NĚMEC, born in 1960 in Boskovice (Czech Republic, Moravia), his mother tongue is Czech. Dominican since 1986, ordained priest in 1991, in the years 1998—2002 he served as a provincial of the Czech Dominican Province. Assistant Professor at the Palacky University in Olomouc, teaching canon law and ecclesiastical law at the Faculty of Theology and at the Faculty of Philosophy. Research worker at the Faculty of Law, University of Trnava (Slovak Republic). Translator of several official documents of the Catholic Church into Czech. Translator of liturgical texts of the Catholic Church into Czech. Member of the Canon Law Society (Prague) and its Institute of Ecclesiastical Law. A member of Consociatio Internationalis Studio Iuris Canonici Promovendo (Roma), Societe International de Droit Canonique et de Legislations Religieuses Comparees (Paris), International Consortium for Law And Religion Studies (ICLARS) (Milano) and the European Society for History of Law (Brno).

ANDRZEJ PASTWA, Dr. iur. can. habil., Head of Department of Canon Law and Ecumenical Theology at the Faculty of Theology at the University of Silesia, and a judge at the Metropolitan Ecclesiastical Court in Katowice. He is a member of Consociatio Internationalis Studio Iuris Canonici Promovendo, Consociatio Iuris Canonici Polonorum, as well as Commission for Polish-Czech and Polish-Slovak Relations of the Polish Academy of Sciences. He has published numerous papers on canon law, especially marriage law, most recently: *Il bene dei coniugi. L'identificazione dell'elemento ad validitatem nella giurisprudenza della Rota Romana*, [Biblioteca Teologica, Sezione Canonistica, 7], Eupress FTL—Edizioni Cantagalli, Lugano—Siena 2018. He is the editor-in-chief of the English-language academic journals: *Ecumeny and Law* and *Philosophy and Canon Law*.

WILHELM REES, Dr. theol. habil, born in 1955 in Augsburg, studied Catholic Theology in Augsburg. He worked as Visiting Professor of Canon Law at the School of Catholic Theology of the University of Bamberg

from 1992 to 1996. Since 1996 he is a Full Professor of Canon Law at the Theological School of the Leopold-Franzens-University, Innsbruck. He has published numerous papers on Canon Law, ecclesiastical law, and civil law concerning religion. He is the co-editor of the new edition of the *German Handbook of Catholic Canon Law (Handbuch des katholischen Kirchenrechts)* (2015) and the co-editor of the German scientific book series *Canonistic Studies and Texts (Kanonistische Studien und Texte*, published by Duncker & Humblot, Berlin).
